Policy for Approval

- Gifts & Hospitality Policy- Approved
- Q: CE observed that if the amount collected by parents to give teachers gifts were to exceed £200 it would need to be declared to tax office.
- A: DK/VF both confirmed that the gifts kindly given to teachers by parents is split between the teaching staff within the class so never exceeds the value of £200 per person.

Head Teacher Report

- Q: Is the PAN lower?
- A: Nursery is very low and Year 6 is also very low. Next year we hope to get 30 into Reception. We had three new pupils actually start today into Years 2,,3 & 5.

- Q: How do we compare nationally with our SEN numbers?
- A: There is no current data to compare nationally. However the I.D.S.R (Inspection Data Summary Report) just released gives some data, but is still based on 2019 stats. DK will send out for Governors to look at.

DK

- Q: Why are you monitoring a significant number of children and is this by the teacher?
- A: Pupils are monitored by the teacher and if they feel further support is required the SENDCO will also monitor to see if additional support is required. The SENDCO works alongside outside agencies to offer this support, which can be social and emotional needs- DESC, or maybe learning difficulties-Learning Difficulties Base.
- Q: Are there 34 children in addition to the Official SEN number?
- A: Yes, realistically the role of SENDCO at the moment should be full-time due to the number of children, however the needs can and are met through quality first teaching in the classroom.DK explained for the new governor's benefit how EHCP funding works and the banding system, and how the 1:1 Teaching Assistants tend to come out of the school budget because we either are awaiting funding or don't receive it.
- Q: Do you need a medical diagnosis to get an EHCP?
- A: No, but it helps speed it up.
- Q: how does the number of FSM compare to national average?
- A: There is no data available to answer the question but the number has increased significantly since Covid 19.
- Q: How do we compare nationally with our absence?
- A: The National average published changes frequently but currently approx 94%. Ofsted are not looking too closely at this at present due to absence from Covid 19, however that will change and we do still focus on any persistent absence.
- Q: Why has it been necessary to go back to Bubbling in school this week?
- A: DK invoked the Outbreak Management Plan with advice from HCC due to the high level of cases in one year group. Year 5 have had 9 positive PCR results so they hit and exceeded the threshold of 5 in a class.DK decided to Bubble the whole school before HCC responded due to other cases throughout the school. HCC confirmed that the correct measures have been adopted and complimented her on her quick, sensible response. There are no staggered start and finish times but the breaks and lunches are staggered and some classes are eating in their classrooms. There is no Collective Worship in the Hall, but this is continuing in their rooms and one class at a time can go to church. There is increased cleaning in school, clubs have stopped if there is more than one year group, fixtures have been cancelled, visitors to school have been limited, and school trips have been rearranged to the new year, including swimming lessons.
- Q: Have you received any feedback to the measures?

- A: Parents have been fantastic and are wearing masks in the playground & when going to the office. Although we can't tell parents to test their children with LFT's we can advocate it and suggest that they might like to test their children, especially in the classes where there has been a significant outbreak. Parents have been embracing this and this has enabled positive cases to be highlighted quickly, especially when the children have been asymptomatic.
- Q: Should parents keep their children off until they get a PCR result?
- A: If the child has gone for a PCR and has symptoms we would expect them to stay off school until they get their result, but if they have had a test just to check, they are allowed to return to school.
- The Bubble for Year 5 will remain as the HCC advice is that it stays for 28 days from the last case, which takes it up to the end of term. The rest of the school Bubbling will be reviewed in two weeks. The children have been amazing- they have been a credit to themselves and very resilient to the changes in working environment/ timetables etc. The Nursery class joined with Reception this week as there have only been two children, so they formed a EYFS unit.
- EH: Thanked DK and team for their speedy response, and work involved in making it so successful and efficient.
- Q: Has the Wraparound provision been affected?
- A: GoldKey are still operating but are keeping family units together and spreading the children out around the Hall.
- MB: Asked VF & CW to be congratulated on their fantastic provision for the Bubbled Year 5 class. "It has been seamless and the online time with their classmates for the isolating children has helped their mental well-being immensely". The blended offer of live teaching and Google Classroom has not been easy for teachers but gratefully received by pupils/parents. The teacher's workload has massively increased as they still have to provide for the children at school but have risen to the challenge.
- Q: Why can Game On still offer a club when others are cancelled?
- A: They can offer two coaches, so can keep Year 3 & 4 totally separate.
- EH: Please feedback to the whole staff how grateful the Governors are for all their extra work and professionalism.
- GDPR: EH: There are no notifiable data breaches. There have been two Subject Access Requests by parents. These have been responded to by staff and were for legal reasons and an EHCP application.
- Q: What is done around Bullying in school and how is it recorded?

- A: It has been a themed Anti-Bullying week this week and school have been focusing on Peer on Peer abuse. The school has its Anti-bullying Policy and bullying is part of the curriculum in PSHE. It is thread through the curriculum through prayers, and Christian values in classrooms, and it is gone back to constantly.
- If there is a case of bullying then SLT work with both the bully & victim and their families. It is monitored closely and diarised in CPOMS. The parents have fortnightly meetings with school and if necessary outside agencies become involved. DK has added tabs onto CPOMS for Sexual Harassment, as this is potentially happening in every setting.
- DK:-the school has had 2 HIP visits this term- reports are on GovernorHub. DK walks the school constantly to assess progress and checks exercise books. There has been huge progress and the children' stickiness in knowledge shows they are remembering more. In English the children are doing Cold and Hot tasks which evidences their improvement. There has been a huge impact for the children due to staff CPD and a focus on monitoring. The children have lost skills during Lockdown and lost stamina in writing due to using screens, but we are starting to see a shift back. It is the same in Maths but is going to be "a Marathon not a sprint".
- Q: How do you anticipate Year 6 will come out of Year 6 SATS?
- A: 14 of them are on the SEN register so we are not confident about the outcome.
- EH: We may need to review how we present the results, especially to new parents who will look at those possible results without a context.
- DK: There have been 5 In –Year admissions into that class and they have all come in with additional needs.
- There has been a push around Phonics within school. Year 2 have their Phonics screening next week and there is a hope that the hard work through catch-up funding interventions by Mrs Drane, Mrs Reid, Miss Craddock and Mrs Paton will have helped the children. Even if the identified children do not pass the school will continue to help them.
- Christmas- DK will review the numbers of Covid 19 before deciding on what can go ahead.
- Q: How did you mark Remembrance in school?
- A: The Reflective Leaders read a poem and prayers outside in the playground with the whole school, Pre-School and members of the community present.
- JR: Members of the community commented about how impressed they were by the children's respect and their engagement was excellent.
- DK: "Immensely proud of each child-they were a credit to themselves, compassionate, thoughtful and respectful".

- GS: This was also reflected on the recent Year 1 trip she attended. The children were a credit to the school.
- PK: Spent a day in school as part of her Governor Induction and reported that the behaviour throughout the school all day was "outstanding".
- VG/PG: Whilst touring the school as new governors they found the children to be "polite and orderly-impressive".
- Q: When talking about quality of education within the deep dive it comments on one teacher not differentiating enough-has this been addressed?
- A: Yes, this particular teacher has received support as this cohort has such a massive range within it.

Curriculum Committee

Minutes were received and approved.

- An Extraordinary meeting will be called to discuss the SIP (School Improvement Plan) so that every governor has a good understanding of how it is written, implemented and the impact.
- There is a new framework for PPG (Pupil Premium grant) which is evidence –based which should be more positive for school.
- Sports Premium- prioritising dance and Gym as these are weaker areas. Game On offer CPD to teachers on teaching Gym for one lesson a week and this is paid for by Sports Premium.
- Spiritual provision- the R.E. curriculum is mapped out and the school uses "Understanding Christianity Scheme". The SIAMS Health check is on GovernorHub for Governors to read.

Resources Committee

Minutes were received and approved.

- Budget- there is extra cleaning which is the effect of Covid 19.
- Over spend on staff- agency staff have been brought in to cover staff absence, training and also to fill a T/A role that couldn't be filled by normal recruitment. A job advert went out yesterday to try and fill this role on a 1 year fixed term contract from January. All new T/A's going forward will be recruited on Fixed Terms.
- The committee Terms of Reference has been amended to reflect the new approval levels and approved by the committee and now FGB.

Nursery

- Nursery- Due diligence has been done on future Nursery provision and thanks go to the working party for their thorough work-PowerPoint on GovernorHub.
- Result of the anonymous vote is confidential at present and is minuted separately.

Christian Distinctiveness

- Children continue to go to church on a Thursday.
